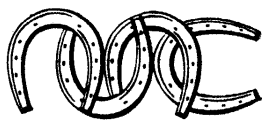

## **OVERSEAS OWNERS – Application & Ownership Criteria**

1. Persons residing in Hong Kong, Macau or China are **not** eligible to apply for this category of ownership.
2. Overseas Owners will be charged an admission fee of HK\$8,000 and a subscription fee of HK\$2,000 per annum. The annual subscription fee will be debited to the Owner's account automatically each year at the beginning of June **unless a written request for resignation of membership is received before that date**. The initial subscription fee will be of the same amount regardless of which month the application is processed.
3. Applicants should fill out the appropriate form and submit it to the Racing Registry Manager with one passport-sized colour photo, a valid passport copy and Credit Card Direct Debit Authorisation Forms for both a primary and secondary back-up card (please specify). An Owner's identity card will be issued and loss of the card will incur a fee of HK\$250. Please note that a 2% service fee is charged by Visa and Mastercard and 2.5% by American Express for all transactions.
4. Applicants should furnish proof of residency abroad and are responsible for keeping the Club updated should any of their contact details be changed. Any documents sent to the registered correspondence address will be deemed to have been received.
5. A maximum of six visits per annum may be made to Taipa Racecourse during which Owners may contact (852) 29226312 for assistance with raceday table reservations, jetfoil tickets and the booking of hotels in Macau. Table reservations may also be made through (853) 3977628. Admission badges will be provided accordingly. All transactions to be settled by cash or credit card.
6. Overseas Owners are only allowed to own a maximum of six horses, whether alone or in partnership. Any requests for exemption to this rule will have to be made in writing to the Racing Registry Manager who will submit the request to Management for their decision.
7. Horses either brought in from overseas or purchased locally under this category of ownership will not be allowed to be sold, or have their composition of ownership changed in any way, for a period of eight months.
8. All charges will be debited to the designated credit card and surplus amounts will remain as a credit balance in the account until it reaches an amount of HK\$50,000 (unless the Club is instructed otherwise), at which time said amount will be forwarded to the Owner via cable transfer. To do so, the Club requires the bank's name and address as well as the applicant's account name and number. Corresponding bank charges will apply. A detailed statement of account will be sent each month to Owners. **Please note that if an account is in arrears by two months, all horses under the account will immediately be put up for tender or auction in accordance with the Club's policy.**
9. Overseas Owners must import a horse within nine months of having their application processed. Should an Overseas Owner dispose of all the horses under his ownership, he must purchase a permit within a six month period in order to retain his status.

## **OWNERSHIP BYE-LAWS**

### **General**

- These Bye-Laws may be revised as necessary by the Racing Committee of the Club from time to time.
- Notification of such changes will be sufficiently published if a Notice is placed on the notice board at the Club's Macau headquarters and shall immediately become binding upon all Members.

### **Definition of an Owner**

Any Member who has successfully purchased a horse or private purchase permit is deemed an Owner once the horse has actually arrived at the Macau Jockey Club and been registered under his name.

### **Categories of Ownership**

- Sole Ownership
- Partnership, consisting of not more than six partners, each of whom must be a Member (a partnership Agreement must be drawn up and signed by all registered owners for the horse concerned and lodged with the Racing Registry Department).
- Corporate Ownership
- Syndicate Ownership (consisting of either between six to twelve persons of which at least one must be a Full Member of the Macau Jockey Club or consisting of five Members of which all five must be Members of the Macau Jockey Club).
- Overseas Ownership

NOTE : Any Owner without a valid Macau or Hong Kong I.D. Card or proof of local residency will be required to lodge a deposit of HK\$10,000 with the Club upon application of membership and a HK\$20,000 deposit for each horse (Overseas Owners exempted).

### **Categories of Horse / Eligibility**

For the purposes of these Bye-Laws, horses shall be deemed to fall into two categories:

- Imported Horses – imported privately, pursuant to a Private Purchase permit issued by the Club.
- Purchased Horses – purchased by auction or tender through the Macau Jockey Club or through private recourse.
- Any Member or registered MJC Syndicate member (on behalf of the syndicate), is eligible to apply for a permit to import a horse or to make a bid on any horse offered for sale by tender or auction.

### **Change of Ownership**

- Any proposal for change in the composition of ownership of any category of horse must be submitted in writing for the approval of the Racing Committee whose determination of such application shall be final and binding for the applicant(s). The Racing Committee shall not be obliged to give any reason for refusing such application.
- Once ownership of a horse has been duly registered, any addition or change of composition of ownership will be subject to a fee of HK\$5,000.
- Should an Owner become ineligible for ownership for whatever reason including, but not restricted to, the termination of membership then, unless the Racing Committee in their sole discretion direct otherwise, ownership of any horse registered in the name of that person, whether as a sole owner or as a managing partner of a partnership or syndicate, will be vested absolutely in the Club, without payment on the part of the Club and without the requirement of any deed or document to transfer ownership.
- The disposal of a horse whose ownership has been vested in the Club shall be at the discretion of the Racing Committee who may allow the horse to continue racing, retire the horse or direct that the horse be offered for sale by tender or auction, in which event the net proceeds of such sale, if any, shall be disposed of at the direction of Racing Committee.
- No person divested of the ownership of a horse by application of this Bye-Law shall have any claim against the Club or any of its employees, for any loss sustained as a result of the enforcement of this Bye-Law.

### **Rules of Racing and Ownership Bye-Laws**

- Each Owner and each Member of a partnership or syndicate shall be deemed to have read and become conversant with and agree to observe and abide by the Rules of Racing, these Ownership Bye-Laws and the Instructions of the Racing Committee in force at the time.
